Instructions for submitting Letters of Recommendation and Statement of Participation will be e-mailed to applicants once their online application is submitted:

Eligibility

- v Applicants must be from racial and/or ethnic underrepresented minority (URM) backgrounds (i.e. American Indian or Alaska Native, Black, African, or African American, Native Hawaiian or Pacific Islander, Non-Caucasian Hispanic or Latinx). REACH accepts applications from medical students, residents, fellows, physician assistant/associate (PA) or nurse practitioner (NP)/advanced practice registered nurse (APRN) students. Other disciplines such as social work and psychology are not eligible to apply
- v Applicants must be in training (i.e. in fellowship, residency, or school) as of July 1, 20 2. Applicants must be U.S. citizens
